He repeated what he has outlined to me on several occasions: We have to set up the Condo docs so that the well owners can override the condo association in taking care of their wells. That is why MA DEP wants to review the documents; they want to ensure this. We will, of course, be following Mass DEP requirements.

Jim said that he reiterated this to the Carlisle Board of Health recently. I presume that was you or Bill so I am under the impression that you know this too.
