


The information on this map is for information purposes only and is not subject to regulations. The information represents the Flood Risk Products and is intended for use in Mitigation and Planning.

Basemap information shown on this FIRM was derived from digital orthophotography. Basemap files were provided in digital form by Massachusetts Geographic Information System (MassGIS). Ortho imagery was produced at a scale of 1:5000 and is dated April 2008. The projection used in the preparation of this map is Massachusetts State Plane Mainland (FIPS:ZONES2001). The horizontal datum is NAD 83, GRS1980 spheroid.

**Flood Zone Definitions:**  
**Special Flood Hazard Area (SFHA)** - The land area covered by the floodwaters of the base flood is the Special Flood Hazard Area (SFHA) on NFIP maps. The SFHA is the area where the NFIP's floodplain management regulations must be enforced and the area where the mandatory purchase of flood insurance applies. The SFHA includes Zones A, AO, AH, A1-30, AE, A99, AR, AR/A1-30, ARI/AE, ARI/AO, ARI/AH, ARI/A, VO, V1-30, VE, and V. Shaded X - Moderate flood hazard areas, labeled Zone B or Zone X (shaded) are also shown on the FIRM, and are the areas between the limits of the base flood and the 0.2-percent-annual-chance (or 500-year) flood. Unshaded X - The areas of minimal flood hazard, which are the areas outside the SFHA and higher than the elevation of the 0.2-percent-annual-chance flood, are labeled Zone C or Zone X (unshaded).

**Risk Product Definitions:**  
**Changes Since Last FIRM** - The CSLF dataset identifies changes in the Special Flood Hazard Area (SFHA) and floodway boundary changes since the previous FIRM was developed. These datasets quantify land area increases and decreases to the SFHA and floodway, as well as areas where the flood zone designation has changed (e.g., Zone A to AE, AE to VE, shaded Zone X protected by levee to AE for de-accredited levees).
