FIREARMS LICENSE APPLICANTS

IN ORDER TO PROCESS YOUR FIREARMS LICENSE APPLICATION YOU WILL NEED TO DO/KNOW THE FOLLOWING:

1. COMPLETE FORM FA-25/26 "COMMONWEALTH OF MASS. CRIMINAL HISTORY SYSTEMS BOARD APPLICATION".
2. BRING APPLICATION FEE OF \$100 (CHECK ONLY) FOR FID AND LTC AT TIME OF APPLICATION. APPLICATION CANNOT BE PROCESSED WITHOUT FEE.
3. BRING CURRENT FIREARMS LICENSE AND CURRENT MASSACHUSETTS DRIVERS LICENSE.
4. FIRST TIME APPLICANTS MUST PROVIDE A "FIREARMS SAFETY CERTIFICATE OR HUNTER SAFETY COURSE CERTIFICATE" (MUST BE FROM MASSACHUSETTS) AT TIME OF APPLICATION.
5. FID APPLICANTS UNDER AGE 18 MUST PROVIDE PROOF OF PERMISSION FROM THEIR LEGAL GUARDIAN AT TIME OF APPLICATION.
6. APPLICANTS FOR "EMPLOYMENT PURPOSES" MUST PROVIDE LETTER FROM EMPLOYER, ON COMPANY LETTERHEAD, AT THE TIME OF APPLICATION.
7. PHOTOS AND FINGERPRINTS WILL BE TAKEN AT THE CARLISLE POLICE DEPARTMENT AT THE TIME OF YOUR APPLICATION. (APPLICANTS ARE **NOT** REQUIRED TO BRING THEIR OWN PHOTOS)
8. CONTACT SGT. CARDONNE (978)369-1155 TO SCHEDULE AN APPOINTMENT TO PROCESS YOUR APPLICATION. THE APPLICATION PROCESS WILL TAKE ABOUT 30-45 MINUTES.

IMPORTANT INFORMATION
Please Read This Entire Document Carefully

IF YOUR APPLICATION IS DENIED, it is usually due to; Disqualifying criminal record, false answer to any question on the application, false answer to any questions asked by the licensing officer during the interview, or criminal information omitted from (or not attached to) the application, as required. As a result of the Gun Control Act of 1998, for the purposes of firearms licensing, all past detentions, arrests, court appearances, juvenile adjudication's, including any "Sealed" records will be accessed and considered in order to determine "suitability" of all applicants for licenses to carry and possess firearms. After having read this entire form, you will be asked specific questions regarding personal background, past criminal history, etc. You must answer all questions fully and truthfully. Failure to do so will result in your application being DENIED. In addition;

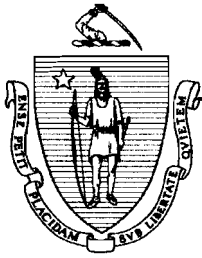
Question # 10 on the application asks, "have you have ever appeared in any court as a defendant for any criminal offense (excluding non-criminal traffic offenses. You do not have to put down non-criminal traffic offenses (the key word here is "appeared", not necessarily arrested). Having been arrested and convicted of a crime does not necessarily prohibit you from getting a License to Carry Firearms or an FID card, not putting it down does.

Please note that, "ever appeared" includes all adult and juvenile court appearances. It does not matter if you were found "not guilty", or "not delinquent", or if the charges were "dismissed", or if the case was "continued without a finding", etc. You have to put it all down. If you do not answer all questions truthfully we will find out, no matter how long ago the incident occurred. If you have a "sealed" record, let us know. You do not have to tell us what the offense is in the sealed record. We will be notified of any sealed record disqualifiers, by the State.

We will not accept excuses such as; "I forgot", or "They told me it wouldn't show up", "It never showed up before", or "It was so long ago I didn't think it mattered now", etc.

Make any necessary changes now. If necessary you can contact the licensing officer for a form to fill out, to request your Massachusetts record check, before you submit your application. You are signing all of these documents under the pains and penalties of perjury. If there are any omissions, or if any false answers are found, you will be denied a license and face criminal prosecution for perjury.
