COVID-19 Safety Information

- During the collection, you will be checked in and waved through without any verbal communication with staff.
- All residents must stay in their vehicles at all times. Clean Harbors has a policy that anyone who attempts to exit their vehicle will be asked to leave.
- Waste will be accepted from truck bed, truck of car, or back hatch of SUV. Clean Harbors will not accept materials from seats or when handed from residents.
- Clean Harbors will not be returning any containers (gas containers, storage totes, etc.). Please plan accordingly.
- Face coverings are required per Governor's Order.

| <p>On the morning of the collection, please drive past the Transfer Station and stop at the foot of Elizabeth Ridge Road</p> | <ul style="list-style-type: none"> • A volunteer will check your car license plate # & blue/yellow sticker – please make sure sticker is visible • Once verified, you will be waved through to the collection area • If you have not pre-registered or don't have a sticker, you will be directed to leave via Elizabeth Ridge Road • For safety reasons, volunteers will not be able to talk to you |

WHAT TO BRING TO THE HAZARDOUS WASTE COLLECTION:

| oil based paints, stains | pool chemicals | spot removers |
| thinners & strippers | aerosol cans | moth balls |

*No medication accepted. SHARPS (NEEDLES, LANCETS, AND EPI-PENS) will be collected in official Sharps containers (red biohazard containers designed for sharps) and sealed with duct tape. Containers are for sale at the Board of Health Offices, Carlisle Town Hall.

NO MOTOR OIL: Arrangements are being made to re-open the motor oil collection tank at the Transfer Station. Stay tuned.

NO LATEX PAINT: These paint cans should be opened, allowed to dry and disposed of in the regular trash collector. Adding kitty litter or spreading latex paint on newspaper to dry will help dry it out

DISPOSE OF AT THE TRANSFER STATION:

CRT RECYCLING: Computer monitors should be left near the swap shop for recycling

BATTERIES: Residents can dispose of ordinary household batteries (AAA - D, Alkaline, nickel cadmium) by giving them to the attendant at the transfer station. There is a regular collection point for lead-acid or car batteries.

PROPANE TANKS to 22 lbs.

MERCURY: Thermostats and thermometers can be dropped off anytime with the transfer station attendant

WE ARE NOT ABLE TO ACCEPT THE FOLLOWING:

Smoke detectors, compressed gas cylinders, ammunition, fireworks or explosives, prescription medicines, radioactive wastes, fire extinguishers, cathode ray tubes, biological waste, unknown materials, or asbestos.
