Dear Neighbor,


The undersigned represents Lifetime Green Homes, LLC in seeking a Comprehensive Permit for the development of the "Brem Property" affordable housing project at 100 Long Ridge Road in Carlisle. As part of the permitting process, the Carlisle Zoning Board of Appeals has requested that we provide well locations and septic system locations for all property within 200 feet of the Project. Additionally, the Board is requiring certain engineering studies which require the collection of data from your well and property. Therefore, I am writing to ask for your permission to allow my client and its agents to enter upon your property for the purpose of surveying the location of your well and/or septic system and to conduct engineering analysis and testing of your property, well and well water (hereinafter the "Work"). All costs and expenses associated with this Work will be paid by my client. There will be no costs or expense incurred by you relative to this Work. Your property will not be adversely affected by the Work and any disturbance of your property will be repaired to the pre-Work condition.

Please note that all properties for which we are seeking permission to conduct the Work may not in fact need to be surveyed or tested. The determination of what Work and which locations will be made by the engineers and consultants contracted to do the Work. Once those determinations are made, you will be notified of when the Work will be done and the specific Work to be done on your property. You will be given more than adequate notice and the Work will be coordinated with you in advance. We are however, seeking the permission of all abutters at this time so as to save time while scope of the required Work is being determined.

If you are willing to grant the requested permission, please sign the acknowledgement below and return it to my office at the address above. I have included a self-addressed envelope with postage for your convenience. If permission is granted, you will be notified in advance of the work to be done on your property and when it will be done.
